The Draconian Act: The Revolutionary Step: Sec 66A of IT act

Not every opinion, given by any ordinary citizen poses threat to public. On social networking sites, blogs and micro blogs we share what we feel. What we share may or may not be correct, accurate and omni-pleasant. Sec 66A of the IT act-2000 defines punishment for sending offensive" messages through any channel of e-communication. A conviction may fetch a term of 3-years in jail and/or a fine. In 2012 there was a PIL filed by a law student Shreya Singhal seeking amendment in the act as the term "offensive" is vague, subjective and the interpretation is varied and contingent to one's way of understanding.

Following the demise of Shiv Sena leader Bal Thackeray in 2012 when a girl posted on facebook and the other liked the post, both were arrested. The arrest was legal but the law through which the arrest was made was more of a draconian and tyrannical taste. Following the incident many petitions were filed and then the act was put under the scanner. Now there is a major breakthrough of thought processes that must be seen.


Internet and e-communications need to be viewed and understood in the right spirit. We have seen the world transforming from pre-internet to internet era. What we learnt and observed in the preinternet times of print media may not be applicable to the internet era. We have to understand that whatever is written may not be of public good or bad.

Since, the most commonly used way of expression on the internet is writing, we need to digest the fact that the source of information has to be checked before the information itself. A random teenager posting some "offensive" remark against the government has to be ignored and if possible educated for what is right. Arrest and litigation for Internet posts doesn't make sense and there will be infinite cases queued up.

Striking down the act, the Supreme Court held, "The information disseminated over the Internet need not be information which 'incites' anybody at all. Written words may be sent that may be purely in the realm of 'discussion' or 'advocacy' of a 'particular point of view'. Further, the mere causing of annoyance, inconvenience, danger, etc., or being grossly offensive or having a menacing character are not offences under the [Indian] Penal Code at all,". The court further said, "Every expression used is nebulous in meaning. What may be offensive to one may not be offensive to another. What may cause annoyance or inconvenience to one may not cause annovance or inconvenience to another.'

We have a right to express and a right to be heard, but we do not hold the right to hurt and the right to offend. As a responsible communicator we must be ethical in terms of disseminating any information over any media. Words are mightier than sword.

In the words of Frank Murphy, "Freedom of speech, freedom of the press, and freedom of religion all have a double aspect - freedom of thought and freedom of action.
